# **COMMISSIONER GABRIELS**EN:

Brush season - Brush truck is in service at the Main house.

When the new engine arrives it will be stationed at the Main House.

The new ambulance is stationed at Main House, as it is four wheel drive for HOH tight spots and Avalon.

The park gets up to 600 visitors a day in the summer season, which results in an increase in calls. There are communication difficulties with Avalon. Would like to hold a drill with Avalon Park rangers.

**APPROVED** on a motion by Commissioner Gabrielsen, Commissioner Scomillio seconds, AIF to purchase 10 radios @ \$580 each for a total of \$5,800 to be able to better communicate with the Avalon Park rangers.

**APPROVED** on a motion by Commissioner Gabrielsen, Commissioner Scomillio seconds, AIF to purchase a cement planter for safety and aesthetics for the Main house behind the bench and 4-3-25 at a price not to exceed \$1,200.
