Received a quote on new District maps of \$5,600. Will need 1 map for each Fire House. Waiting for a quote from H2M.

The Civil Service list for EMS Coordinator has been canvassed with no responses. Can now go out to the general public. Will work with Commissioner Gabrielsen on the interviews.
