ADD-ONS:

Revised the EMS payroll to reflect correct Holiday pay for Labor Day for part-time EMS employees.

The August meeting minutes were **APPROVED** as written on a motion by Commissioner Scomillio, Commissioner Young seconds, AIF.

COMMISSIONER SCOMILLIO:

Bill Glass approved the accident policy and sent a suggested accident investigation policy (this is required under PESH).

Asks Chief Orth to look into training for floods – appropriate PPE, boots, gear. We need to be better equipped in the event of another flood.

New engines – motors are on the bottom instead of the top of the vehicle. Will need to be mindful of this in the event of a storm.

COMMISSIONER GABRIELSEN:

Trauma bags for ambulances: Commissioner Gabrielsen motions to spend \$1,727.16 for 15 bags, Commissioner Young seconds, AIF. Commissioner Donohue mentions to make sure Donna gets the invoice for this.

PPE for ambulance shoes and pants – volunteers should have the same gear as paid personnel:

\$3,000 boots

\$1,200 pants

APPROVED on a motion by Commissioner Gabrielsen, Commissioner Young seconds, AIF to spend up to \$4,500 for pants and boots. Will run this by the captain of ambulance.

Heat for Station 3- got a price quote of \$60,000 for 2 split units – will do further research. Commissioner Donohue asks if there is an exhaust fan. Ed to look into this.

The generator project bid opening will be held on Thursday 9/12 at 3:00PM.

Got a quote for ceiling tiles in the amount of \$9,244. **APPROVED** on a motion by Commissioner Gabrielsen, Commissioner Scomillio seconds to spend up to \$10,000 on ceiling tiles. AIF. Sole source paperwork to be provided.

COMMISSIONER DONOHUE:

Price for new hose will be approximately \$30,000.

Price quote for removing and replacing radios in new engines and customized shelving is \$35,313.71 per engine. This was **APPROVED** on a motion by Commissioner Donohue, Commissioner Scomillio seconds, AIF

Price for striping new engines \$7,500 per engine. This was **APPROVED** on a motion by Commissioner Donohue, Commissioner Scomillio seconds, AIF.

New ambulances- no answer from Proline as to what still needs to be completed. No update on Chief's car.

COMMISSIONER YOUNG:

Asks about the status of 4-3-6C- Ed will look into this. Same problem and same error code every time.

Ambulance billing status? Expecting a start date soon. We are able to bill back as far as April, 2024.

Meeting was adjourned at 8:20PM on a motion by Commissioner Donohue, Commissioner Scomillio seconds, AIF.
