Would like to purchase 2 new radios for the Suburban @ \$8,373.45 per year. **APPROVED** on a motion by Commissioner Theobalt, Commissioner Donohue seconds, to spend up to \$17,000 on 2 new radios. AIF.

COMMISSIONER YOUNG:

Uniforms –10 new last year. This year 5

Expiration on fire gear? 10 years – just ordered 70 sets.

Chief Keegan asks if we can put in for 10 new uniforms this year – everything in the closet is very large. Will go through the closet.

Can we discuss an item from the EMS Coordinators report in Executive session?

Commissioner Gabrielsen asks who ordered the new gear. No one seemed to know. All orders must go through Ed.

The 10-year expiration on gear is not true according to the NFPA. Chief Keegan mentions that according to OSHA and PESH it is 10 years. Also not 10 years for bailout gear.

Commissioner Theobalt mentions that if anyone has questions or concerns about the bail out gear please put it out of service and we can address it at the next meeting.

Commissioner Theobalt also mentions that the wrong truck was lettered. Neither truck was here that was supposed to be lettered.
